As the building design and construction industry looks at the composition of the future workforce, it is clear that the demographics of today's workforce will need to change to meet future demand for employees. It is projected that this change will include increasing the number of women employed in the building design and construction industry. We have seen an increase in young women enrolling in STEM disciplines at the university level and an improvement in the number of women students attaining college degrees, but we have not seen the same increase in the percent of women employed in the STEM workforce. This inconsistency can be attributed to poor retention of women once they enter the profession. This presentation will address why women leave the industry and what can be done to help increase retention. This is an important topic for our industry as a whole as well as for employers trying to minimize turnover and maximize productivity and profit.

About the Speaker: Julia Keen is a Professor in the GE Johnson Department of Architectural Engineering and Construction Science at Kansas State University holding the Bob and Betty Tointon Engineering endowed chair. She also owns her own consulting company, Keen Designs, PA. Her specific areas of interest include HVAC design, energy codes, high performance design, HVAC education, and the advancement of women in the building design and construction industry.

Julia Keen received her Bachelor's Degree in Architectural Engineering from Kansas State University. Upon graduation, she worked as a Mechanical/Electrical Project Engineer in Waterloo, Iowa. In this capacity she was responsible for the design of building systems from initial planning stages through final project inspection and completion. In July 2003, Julia accepted a faculty position with K-State in the Architectural Engineering and Construction Science Department. She completed her Master's degree in Architectural Engineering (2005) and her Doctorate (2010) in Education both from K-State. She is a Licensed Mechanical Professional Engineer in Kansas and Iowa and holds the ASHRAE Certification – High-Performance Building Design Professional (HBDP).

In addition to her 9-month faculty appointment at K-State, Julia has the opportunity to stay current with the HVAC industry in a consulting capacity. Her consulting endeavors include performing as HVAC professional education consultant, engineering design, plan check and quality review, and acting as an owner's representative in facility planning and project implementation.

Julia became involved in ASHRAE as a student member of the Kansas State University student branch. She has acted as the faculty advisor to this branch since 2003 during which time the chapter has routinely attended the ASHRAE winter meetings and the competition team that she has coached has finished first in the ASHRAE Design Competition six times. Through the years, Julia has held several chapter positions including President of the Cedar Valley Chapter. She has also been involved in many Society level committees including: Finance, Publishing and Education Council, Planning, Publications, Conferences and Expositions, and Certification as well as chaired TC6.1-Hydronic and Steam Equipment and Systems. Julia served in the elected positions on the ASHRAE Society Board of Directors as Vice President (2017 - 2019) and Director-at-Large (2013 - 2016). As a DAL and VP she served as Ex Officio/Coordinating Officer to the Refrigeration, Society Rules, and Standards Committees and was a voting member of Tech Council. Her service to the organization was recognized in 2024 when she was given the Exceptional Service Award. Julia continues to promote her passion of HVAC education through the HVAC Essentials Course she co-developed and delivers for ASHRAE around the world. She was promoted to the grade of ASHRAE Fellow in 2016 and was presented with the 2018 ASHRAE E. K. Campbell Teaching Award.



A Note From the Editor

We are excited to be relaunching *The Oregon Diffuser* this year! As many of you may know, the *Oregon Diffuser* was the second chapter newsletter in ASHRAE, with its first publication in **1946**. As I prepared for this first issue, I had the honor of sitting down with past editor and friend (and Past Oregon Chapter President / Region XI Director and Regional Chair) **Kevin Marple** to discuss the history of the newsletter and reflect on the evolution from physical printing and mailing to our current digital format. As we launch the 2024-25 edition of **The Oregon Diffuser**, we look back at the history of this important publication by revisting "The Birth of the *Oregon Diffuser*," an article written by Bruce Morrison for the October 1996 issue, and take a look at the cover of the very first issue, published in 1946.

Birth of The Oregon Diffuser

by Bruce Morrison

J. Donald Kroeker and I would sometimes have lunch together at Manning's Cafeteria on Fourth and Alder Streets. in the fall of 1945 after I had opened my office we had several discussions about ASHRAE, and Don was always generous with suggestions or help. One of the things he wanted to see for the chapter was a publication that would help us to be more closely knit and provide more service to the industry. At that time there was only one other chapter of ASHVE. I was hesitant about recommending it to the Board of Governors due to the need for an editor who could put in the necessary time to prepare the publication for printing. At the Board of Governors meeting in May 1946 it was discussed and, on the basis that Don Kroeker would act as editor, the Board of Governors approved it. I cannot remember whether the chapter voted on it or not in May. However, the first issue was born and placed in the mail for delivery a week before the October meeting in 1946.

Originally the **Diffuser** started as a monthly publication. The issue is published before each meeting of the Oregon chapter. It is interesting to note that in the **Prexy's Words** of **Wisdom** in the first issue, I first thanked Don Kroeker for starting and editing the **Oregon Diffuser**. I next had the pleasure of thanking the chapter for their response to providing travel funds for Professor Willey to present the only chapter-sponsored research "Heat Loss through Wetted Walls" at the summer meeting in Montreal, Canada. The chapter's committees were a delight because of their interest in bringing in new members to the chapter, putting on the air conditioning conference, and providing programs for the meetings. In closing my words of wisdom, I suggested we try to have as many guests as possible to hear the National ASHVE president, Alfred Offner, who was the speaker for our October 1946 meeting.

The first issue of the Diffuser had a picture of the attendees of the third HVAC conference, which was the first sponsored by the Oregon chapter of ASHVE. As I recollect, attendance was about 90 to 100.





- Any extra growth over 5% can be disbursed as needed of can be reinvested into the principal.
- Any contribution still counts as an RP donation.
- Application draft is available for the Chapter to review if we want to pursue this.
